

Aloha Bonaire Car Rental Terms and Conditions

1. **Authorized Drivers: Lessee and "additional driver(s)" only**, as mentioned in the rental agreement, are authorized to drive the vehicle. If an accident occurs and the driver is not the Lessee or "additional driver(s)", the Lessee will be held **fully responsible** for all direct and indirect damages/losses.

2. **Insurance Options:**

- 2a. **CDW (Basic insurance included in Rent)**: If accepted, the **deductible is \$500** for cars and **\$600** for Pickups, Jeeps, SUVs, and Vans. **CDW does not cover "one-way" accidents, Driving under the influence of alcohol or drugs, speeding, off-road driving,** or third-party damages exceeding **\$50,000**. A **valid police report** is mandatory. In case **CDW is not accepted**, the lessee will be **responsible** for the total amount of **damage/losses**.
- 2b. **Full Insurance (All risk premium insurance)**: If accepted, the **deductible is \$100**. It covers **theft, joy-riding, and "one-way" accidents**. It **does not cover Driving under the influence of alcohol or drugs, speeding, off-road driving,** or third-party damages exceeding **\$50,000**. A **police report** is mandatory. In case **Full Insurance is not accepted**, the lessee will be **responsible** for the total amount of **damages/losses**.

Please be advised: that **insurance coverage (Both basic and Premium insurances) is strictly invalidated** in the event of an accident involving driving under the **influence of drugs or alcohol**, or during unauthorized **off-road use**. In case **Insurances is not accepted**, the lessee will be **responsible** for the total amount of **damages/losses**.

3. **Damages and Losses Price List:**

- Gas cap: \$20 | Hub cap: \$60 | Wheel wrench: \$35 | Jack: \$100 | Jack handle: \$30
- Antenna: \$40 | Radio: \$200 | Battery: \$150 |
- **Tires:** Car \$100 | Jeep, SUV, Pickup \$200
- Rims (Aluminum): Car \$120 | Jeep, SUV, Pickup \$170
- **Keys:** Standard \$20 | Chip \$160 | Chip & Remote \$260 | **Lockout service \$20**

Please note: Listed prices are for damages. **Broken items must be paid in full.**

4. **Off-Road Driving:** Driving **off-road**, on **white sand**, and/or **dunes is not permitted**. Any damage caused by this is for the **lessee's account**.

5. **Fuel Policy:** Vehicle is delivered **full** and must be **returned full**. Missing fuel is charged at **\$20 per 1/8 tank** (cars) or **\$25 per 1/8 tank** (Jeeps/SUVs/Vans/Pickups). **No refunds** for extra fuel.

6. **Accidents:** In case of an accident, **call CRS Caribbean Road Service** at +599 717 9292 or Whatsapp:+599 795 9292. A **police report** must be filled out at **all times**.

7. **Flat Tires:** Assistance for a flat tire near town is available. The **repair cost is \$35**.

8. **Returns:** Vehicles must be returned to the **same pick-up location**. For changes, notify the office at +599 785 5999.

9. **Cleanliness:** Vehicle must be returned **clean**. If not, the Lessee will be charged for cleaning and repair/replacement costs. The company is **not responsible for personal belongings**.

10. The Lessee assumes **full liability** for any damages or losses, including **water damage**. We kindly ask that any associated costs be **settled prior to departure**.

11. **Payment Authorization:** Lessee gives **power of attorney** to use any provided **credit card** to pay for damages or losses.

12. **Soft-top Jeeps:** Tops must be **closed overnight** and when it **rains**. Failure to do so makes the Lessee liable for any **interior electrical damage**.

13. **Jurisdiction:** Only **Bonaire law** applies to this rental agreement.
